*THIS CONTRACT MUST BE POSTMARKED NO LATER THAN FEBRUARY 8, 2010. Contracts must bear an official U.S. Postal Service postmark of **FEBURARY 8, 2010** or earlier to ensure acceptance. A metered postmark will not be considered as a valid postmark.

***THIS CONTRACT IS NOT A SHOW ENTRY; HOWEVER THIS FORM MUST BE ON FILE FOR ALL MARKET ANIMALS ENTERED.** Exhibitors are responsible for entering all market animals and paying entry fees. All entries must be done online by visiting www.cowpalace.com and clicking the link for online entries. Entry deadline is March 29, 2010.

The following must be attached to this contract:

*A COPY of the bill of sale or a bred and owned statement.

*A total of three pictures as follows: A picture of the front, left and right profile of the animal.

On-Line Entry Deadline: Monday, March 29, 2010

1. **The Market Swine Show is NOT CJLA Sanctioned.**
2. **OWNERSHIP: EXHIBITOR MUST OWN MARKET ANIMALS 60 CONSECUTIVE DAYS PRIOR TO APRIL 7, 2010. All market swine must be owned by the exhibitor no later than February 7, 2010.**
3. **Exhibitors must submit a Market Swine Contract to the Cow Palace office no later than February 8, 2010.**
4. Hogs will be broken into the following breeds at the scale: Yorkshire, All Other Purebreds and Crossbreds. Any other breed that has 15 or more animals upon the conclusion of weight in will be broke into their own division. The decision of the breed classifier is final. Each breed will be broken into classes based upon weight. The number and weight of entries will determine the number of classes.
5. Minimum market weight will be 210 pounds. Maximum weight is 280 pounds. Any entry weighing over 280 pounds will be sifted and not be allowed to show.
6. All Market Swine must be tagged with a Grand National Ear Tag Prior to weigh in. Ear Tags will be available from the Lamb Superintendent's Office.
7. Exhibitors MUST WEAR official 4-H, FFA, Grange or Independent Uniforms.
8. **PREMIUM MONEY IS NOT OFFERED IN THE MARKET SWINE DIVISIONS.**
9. Grange and Independent exhibitors that are in the 8th grade or below will compete with 4-H Members. Grange and Independent exhibitors that are in 9th grade or above will compete with FFA Members.
10. The Supreme and Reserve Supreme Champion Market Swine Awards will be presented during the awards ceremony. Attendance by exhibitor at this presentation is mandatory. In the event the exhibitor does not attend, the award will be withheld.
11. **The Supreme and Reserve Supreme Champion animals are no longer terminal.**
12. **All Market Swine must weigh in on Thursday, April 8, 2010.** Times will be published in the official premium book. The weigh in order will be determined by the Specie Superintendent and will be posted in the barn.
13. Any Market swine not meeting the minimum weight requirement at the time of the official weight in may be transferred into the open junior "Classic" Division for that specie. **The exhibitor is responsible for requesting the transfer and it must be done immediately following the animal being removed from the scale.** Complete rules for the Classic Show will be listed in the official premium book.
14. Clipping of any hog will not be permitted on the Cow Palace grounds. If an exhibitor chooses to clip his/her animal(s) it must be done prior to arrival on the grounds. Any violator of this rule will have all entries pulled and will not be allowed to show.
15. **No health certificates are required for Market Hogs.**
16. Weighbacks will be utilized at the discretion of management. Weigh back allowances will be posted at the show.
